About Our Work:

LCCR protects the constitutional right to an attorney for more than 90% of New Orleans' children in the juvenile legal system – <u>541 children</u> in FY25. Additionally, through our partnership with the East Baton Rouge Office of the Public Defender, we provided social work support to another <u>165 children</u> last year. We're so much more than a nonprofit law office though. We meet our kids at a moment of crisis and provide the wraparound services necessary to leave the legal system behind for good. We help our kids enroll in school, secure special education supports, access job training, and address trauma.

As a result, more kids are staying in their homes, schools, and communities, and staying out of prison. This means healthier young people, safer neighborhoods, and saved taxpayer dollars. We're continually inspired by the strength of our kids and how, working with LCCR's programming, they build brighter futures for themselves.
